Please note there is a required deposit for access during this period (see Traffic coordination at the download center of the site of the event). On the last day of the exhibition access is only possible until 2 hours before closure of the event.
- Exhibitor parking space is available at the user's risk. Messe Berlin is not liable for damage to persons or property, especially not in case of stolen vehicles. Parking is only permitted in the places allocated, so to not adversely affect the operation of the fair. This is in the interest of all exhibitors and visitors.
- The passes will be charged by MB Capital Services GmbH on behalf and on account of Messe Berlin GmbH. The General Terms of Business of Messe Berlin GmbH are valid.
